ILC Academic Rules - Approved by the Committee of Courses, Faculty of Law, DU, 13/12/2024

FACULTY OF LAW UNIVERSITY OF DELHI Five-Year Integrated Law Course (ILC) B.A. LL.B. (H) and B.B.A. LL.B. (H)

Academic Rules

1. These Academic Rules shall apply to Five-Year Integrated Law Course (ILC), B.A. LL.B. (H) and B.B.A. LL.B. (H). In addition to these Academic Rules, all other rules of University of Delhi shall also apply.

2. Attendance Rules

All the students of B.A. LL.B. (H) and B.B.A. LL.B. (H) shall have to put in minimum attendance of 70% of the lectures in each of the subjects as also at the moot courts, tutorials and practical training subject conducted or taught in a semester for taking the examination.

Provided that if a student for any exceptional reasons fails to attend 70% of the classes held in any subject or training subject, the Dean of the Faculty of Law, may allow the student to take the Examination for the semester if the student concerned attended at least 65% of the classes held in the subject concerned and attended 70% of classes in all the subjects taken together in all the subjects of the semester.

Provided further the Dean, Faculty of Law or a committee constituted by the Dean in this regard may relax absence from classes (of fifteen days in one semester and a maximum of twenty days in an academic year for participating in recognized moot court competitions, seminars and conferences, legal aid camps and activities, sensitization programmes, permitted and approved internships, training programmes relevant to legal education, permitted attendance in court and for unforeseen circumstances.

The Dean of the Faculty or Director of Integrated Law Course (ILC) shall have power to strike off the name of a student who is grossly irregular in attendance in spite of warning, or, when the absence of student is for such a long period that he/she cannot put in requisite percentage of attendance for the semester.

3. Promotion Rules

- (i) No student shall be promoted to the next Term, if he/she has been detained in the examination for shortage of attendance.
- (ii) Subject to sub-rule (i) above, a student of B.A. LL.B. (H) and B.B.A. LL.B. (H) First, Third, Fifth, Seventh, or Ninth Term shall be eligible for promotion to Second, Fourth, Sixth, Eighth or Tenth Term, respectively irrespective of the number of subjects in which he/she has failed to pass or failed to appear in the First, Third, Fifth, Seventh, or Ninth Term examinations.

- (iii) Subject to sub-rules (i) and (ii) above,
 - a) a student of Second Term shall be eligible for promotion to Third Term if he/she has passed in at least six papers of First and Second Term examinations taken together;
 - b) a student of Fourth Term shall be eligible for promotion to Fifth Term if he/she has passed in at least eighteen papers of First, Second, Third and Fourth Term examinations taken together;
 - c) a student of Sixth Term shall be eligible for promotion to Seventh Term if he/she has passed in at least thirty papers of First, Second, Third, Fourth and Fifth Term examinations taken together;
 - d) a student of Eighth Term shall be eligible for promotion to Ninth Term if he/she has passed in at least forty-two papers of First, Second, Third, Fourth, Fifth, Sixth, Seventh and Eighth Term examinations taken together;

Note:- The students eligible for admission to III/V/VII/IX Term must seek admission not later than two weeks from the date(s) of announcement of the results of B.A. LL.B. (H) and B.B.A. LL.B. (H) II/IV/VI/VIII Term Annual Examinations or within one week of commencement of teaching, whichever is later, failing which they will forfeit their right to be admitted to III/V/VII/IX Term in the particular year.

For the purpose of promotion of the students of Batch 2023-2028 to III Semester, the above rule 3 (iii) (a) will not apply. For promotion to all other semesters, all rules will apply to them.

4. Assessment Pattern

- (i) A student must pass all the subjects specified as part of their curriculum of the Five-Year Integrated Law Course to be eligible to obtain the B.A. LL.B. (H)/B.B.A. LL.B. (H) Degree.
- (ii) The following shall be the Assessment Pattern for Five-Year Integrated Law Course, B.A. LL.B. (H) and B.B.A. LL.B. (H).

(iii) The students who have secured more than 70% attendance in a subject shall be awarded marks for attendance as per the following criteria:

Percentage of attendance	Marks to be awarded		
More than 70% but less than 75%	1		
75% or more but less than 80%	2		
80% or more but less than 85%	3		
85% or more but less than 90%	4		
90% and above	5		

(iv) Pass percentage in every subject shall be 45% of the total marks obtained after combining all components of assessment in that subject.

However, for the subjects Moot Court Exercise and Internship 1-A, 1-B, 1-C, the assessment will be based on Internship Diary/Court Diary (75 marks) and Viva voce examination (25 marks). There will be no minimum passing marks for these papers.

For Internship in X Semester, the assessment will be based on Internship Diary/Court Diary (75 marks) and Viva voce examination (25 marks) and pass percent will be 45% of the total marks obtained.

Minimum 20 weeks of internship is mandatory to be awarded with the degree.

(v) A student who has not secured the requisite pass percentage in a subject or was absent but otherwise eligible to appear in the exam, shall be allowed to take the end term exam held for that subject as and when held in the subsequent year(s), provided, s/he fills in the examination form within the timeframe specified by ILC.

Note: The student appearing in the subjects(s) as per Rule 4 (v) will be not be assessed again for the mid-term exam, project/assignment, viva voce/presentation and attendance and the marks obtained earlier shall be carried forward.

5. Re-admission Rules

- (i) There shall be no re-admission in the B.A. LL.B. (H) and B.B.A. LL.B. (H) First Term under any circumstances including detention for shortage of attendance in that Term.
- (ii) A student who has been detained for shortage of attendance or for applying late for admission in Second, Third, Fourth, Fifth, Sixth, Seventh, Eighth, Ninth or Tenth Term shall be eligible for re-admission in the same Term in which he/she had been detained, provided
 - (a) he/she seeks readmission before commencement of teaching in the relevant Term;
 - (b) his/her conduct has been satisfactory; and
 - (c) he/she shows sufficient cause for his/her discontinuance of studies or for not having put in the requisite percentage of attendance to the satisfaction of a Committee consisting of the Dean, Faculty of Law and the Director of Integrated Law Course (ILC).
- (iii) An applicant who has failed in examination or failed to appear at the examination and who is otherwise eligible to appear at the examination as an ex-student, shall not be admitted as a regular student. In exceptional cases, however, where such an applicant is a foreigner, studying under the Cultural Scholarship Scheme of the Government of India, etc., re- admission may be allowed.
- (iv) In respect of an applicant seeking re-admission, his previous record shall be carefully scrutinized at Integrated Law Course (ILC).

6. Pass percentage and Classification of Successful Candidates

The following shall be the percentage of marks for passing the examination and for classification of successful candidates admitted to the LL.B. course:

- (i) A candidate must pass in all 59 subjects in Ten Terms to be eligible to obtain the B.A. LL.B. (H)/ B.B.A. LL.B. (H) Degree;
- (ii) A candidate securing 60% or more marks in the aggregate in all 59 subjects taken together will be awarded First Division;
- (iii) A candidate securing 50% marks but not less than 60% marks in the aggregate in all the 59 subjects taken together will be awarded Second Division;
- (iv) A candidate securing 45% but less than 50% marks in the aggregate in all the subjects taken together will be awarded Third Division;
- (v) The Distinction in any paper(s) of a Term will be awarded only to those candidates who passed in all papers of the Term concerned in one attempt in normal course securing 75% marks in the paper(s) concerned.

7. Improvement of Previous Performance

- (i) A student studying in the Third Term may be permitted to surrender his/her result of any subject of the First Term within one month of the commencement of the Term provided:
 - (a) he/she has passed that subject in the first attempt; and
 - (b) at the time of surrendering his/her result, he/she has passed at least 6 other subjects of the First and Second Terms taken together excluding the subjects the result of which he/she wishes to surrender.
- (ii) A student studying in the Fourth Term may be permitted to surrender his/her result of any subject of the Second Term within one month of the commencement of that Term provided:
 - (a) he/she has passed that subject in the first attempt; and
 - (b) at the time of surrendering his/her result, he/she has passed at least 6 other subjects of the First and Second Terms taken together excluding the subjects the result of which he/she wishes to surrender.
- (iii) A student studying in the Fifth Term may be permitted to surrender his/her result of any subject of the Third Term within one month of the commencement of that Term provided:
 - (a) he/she has passed that subject in the first attempt; and
 - (b) at the time of surrendering his/her result, he/she has passed at least 18 other subjects of the First, Second, Third and Fourth Terms taken together excluding the subjects the result of which he/she wishes to surrender.
- (iv) A student studying in the Sixth Term may be permitted to surrender his/her result of any subject of the Fourth Term within one month of the commencement of that Term provided:
 - (a) he/she has passed that subject in the first attempt; and
 - (b) at the time of surrendering his/her result, he/she has passed at least 18 other subjects of the First, Second, Third and Fourth Terms taken together excluding the subject the result of which he/she wishes to surrender.
- (v) A student studying in the Seventh Term may be permitted to surrender his/her result of any subject of the Fifth Term within one month of the commencement of that Term provided:
 - (a) he/she has passed that subject in the first attempt; and
 - (b) at the time of surrendering his/her result, he/she has passed at least 31 other subjects of the First, Second, Third, Fourth, Fifth and Sixth Terms taken together excluding the subject the result of which he/she wishes to surrender.

- (vi) A student studying in the Eighth Term may be permitted to surrender his/her result of any subject of the Sixth Term within one month of the commencement of that Term provided:
 - (a) he/she has passed that subject in the first attempt; and
 - (b) at the time of surrendering his/her result, he/she has passed at least 31 other subjects of the First, Second, Third, Fourth, Fifth and Sixth Terms taken together excluding the subject the result of which he/she wishes to surrender.
- (vii) A student studying in the Ninth Term may be permitted to surrender his/her result of any subject of the Seventh Term within one month of the commencement of that Term provided:
 - (a) he/she has passed that subject in the first attempt; and
 - (b) at the time of surrendering his/her result, he/she has passed at least 44 other subjects of the First, Second, Third, Fourth, Fifth, Sixth, Seventh and Eighth Terms taken together excluding the subject the result of which he/she wishes to surrender.
- (viii) A student studying in the Tenth Term may be permitted to surrender his/her result of any subject of the Eighth Term within one month of the commencement of that Term provided:
 - (a) he/she has passed that subject in the first attempt; and
 - (b) at the time of surrendering his/her result, he/she has passed at least 44 other subjects of the First, Second, Third, Fourth, Fifth, Sixth, Seventh and Eighth Terms taken together excluding the subject the result of which he/she wishes to surrender
- (ix) A student who has been promoted to the Tenth Term may be permitted to surrender the results of not more than two subjects of the Ninth Term within one month of the commencement of the Term or the publication of the result of the Ninth Term, whichever is later. In such a case, he/she will take the supplementary examination in those subjects to be held in that year subject to his/her being eligible for the benefit of supplementary examinations.
- (x) A student who has passed in all the subjects of the Tenth Term may, within one month of the declaration of the result of Tenth Term examination, surrender his/her result of not more than two subjects of the Tenth Term along with a declaration that he/she will not seek enrolment or employment or any other benefit on the basis that he/she has passed the B.A. LL.B. (H)/B.B.A. LL.B. (H) examination till such time the result of the subjects in which he/she wishes to improve his/her performance has been declared. He/she will take the examination at the next available opportunity.
- (xi) Such candidates who surrender results in order to improve their performance will take the examination in the current question paper based on the latest syllabus along with the regular students of that year.

- (xii) The improvement examination shall be for the marks assigned to the End-term examination only. The students shall not be allowed to seek improvement in the marks already obtained in the mid-term examination, project and viva voce/presentation and attendance and the marks shall be carried forward.
- (xiii) The results of the dissertation and internship subject(s) cannot be surrendered for improvement.

8. Supplementary Examination

- (i) After the completion of Ten Terms, a student of B.A. LL.B. (H) and B.B.A. LL.B. (H) may take supplementary examination in any paper of I or III or V or VII Term along with the IX Term supplementary examination and in any paper of II or IV or VI or VIII Term along with the X Term supplementary examination held for the purpose: Provided that all the fifty nine papers required for getting the B.A. LL.B. (H)/B.B.A. LL.B. (H) Degree have to be cleared within the span period of Eight years.
- (ii) The supplementary exam will be conducted for the end term exam component only. The student will not be assessed again for the mid-term exam, project/assignment, viva voce/presentation and attendance and the marks obtained earlier on these components shall be carried forward.

9. Span Period

Subject to the provisions contained in the Ordinance relating to ex-students as in force from time to time, a student must clear all the subjects offered in all the Terms within a span period of eight years from the date of admission to first year of the B.A. LL.B. (H)/B.B.A. LL.B. (H) course. No student shall be admitted as a candidate for any B.A. LL.B. (H)/B.B.A. LL.B. (H) examination after eight years from the date of admission to the first year of the course.
